

KIPP New Orleans Schools Board Meeting Minutes: April 20, 2023

A public meeting of the Board of Directors (the Board) of KIPP New Orleans Schools (KNOS) was held on Thursday, April 20, 2023, at KIPP New Orleans Schools, 1055 St. Charles Avenue, Suite 400, New Orleans, LA 70130.

The meeting was called to order at 5:45 p.m.

Approval of Minutes

CEO Report/Academic Committee Report

Ms. Kalifey-Aluise opened the CEO Report. She introduced guest speaker, Dana Peterson, CEO of New Schools for New Orleans. Mr. Peterson gave a presentation detailing Senate Bill 25.

Finance Committee Report

Ms. Willis reported that the Finance Committee met on April 20th and reviewed the current financial summary. Ms. Walmsley presented the current FY23 financial summary and provided an update on enrollment.

Governance and Nominating Committee Report

Members shared feedback about their meetings with Ms. Handy. Mr. Washington introduced a motion to elect Shana Handy as a board member of the KNOS Board of Directors. A motion to approve was made by Mr. Bailey and seconded by Dr. Hurley. The motion passed by a unanimous voice vote.

Lastly, Mr. Bailey reminded board members to complete their annual Tier 3 Financial Disclosure statements, their annual conflict of interest forms, and to update their contact information if necessary.
